Scope of this Policy

This privacy policy applies to:

If a change is made you will have a reasonable opportunity to withdraw your consent to any further materially different collection, processing, or transfer of previously collected personal data under the changed policy.

Information We Collect

We collect information from you directly, from the devices you use to interact with us, and from third parties. We may combine information from the Services with other information we obtain from our records. We may use and share information that we aggregate (compile to create statistics that cannot identify a particular individual) or de-identify (strip information of all unique identifiers such that it cannot be linked to a particular individual) at our discretion.

Information you give us

You may provide the following information to us directly:

Information we collect automatically

We and partners working on our behalf may use log files, cookies, or other digital tracking technologies to collect the following information from the device you use to interact with our Services. We also create records when you make purchases or otherwise interact with the Services.

- *Device information*, including IP address, device identifiers, and details about your web browser.
- *Analytical information*, including details about your interaction with our website and electronic

Information We Collect from Other Sources

We may collect the following information about you from third-party sources.

- Contact information, demographic information, and information about your interests and purchases, from consumer data providers and organizational partners.
- Information about your interests, activities, and employment history from social networks and other places where you choose to share information
- Information about your interaction with advertisements on our Services, or ads that we place on third party websites, from online advertising
- If you decide to invite others to the Services, we will collect your and the other person's names, email addresses, and/or phone numbers to send an email or text message and follow up with the other You agree that you will obtain the other person's consent before giving us the other person's contact information. How We Use Your Information

We may use any of the information we collect for the following purposes.

- **Service functionality:** To provide you with our services, including to facilitate account registration, offer our membership services, process donations, send service and policy-related communications, administer surveys, and conduct general business operations, such as accounting, recordkeeping, and
- **Service improvement:** To improve and grow our Services, including to develop new products and services and understand how our Services are being used, our membership base and purchasing trends, and the effectiveness of our
- **Personalization:** To offer you recommendations and tailor the Services to your preferences, including utilizing image recognition technology to automatically organize and tag media content for better user navigation and profile customization, and to offer you content and services that may be of interest to you based on the content that you have viewed on our website or other.
- **Advertising and marketing:** To send you marketing communications and measure the effectiveness of our We may share your information with online advertising partners and social media platforms for this purpose.
- **Security:** To protect and secure our Services, assets, network, and business operations, and to detect, investigate, and prevent activities that may violate our policies or be fraudulent or illegal.
- **Legal compliance:** To comply with legal process, such as warrants, subpoenas, court orders, and lawful regulatory or law enforcement requests and to comply with applicable legal requirements.

How We Share Your Information

We may share any of the information we collect with the following recipients.

- **Service providers:** We engage vendors to perform specific business functions on our behalf, and they may receive information about you from us or collect it. These vendors are obligated by contract to use information that we share only for the purpose of providing these business functions, which include:
 - *Supporting Service functionality*, such as vendors that support event registration, customer surveys, subscription fulfillment, freight services, application development, list cleansing, postal mailings, and communications (email).
 - *Auditing and accounting firms*, such as firms that assist us in the creation of

our financial records.

- *Professional services consultants*, such as firms that perform analytics, assist with improving our business, provide legal services, or supply project- based resources and assistance.
- *Analytics and marketing services*, including entities that analyze traffic on our online properties and assist with marketing efforts.
- *Security vendors*, such as entities that assist with security incident

verification and response, service notifications, and fraud prevention.

- *Information technology vendors*, such as entities that assist with website design, hosting and maintenance, data and software storage, using artificial intelligence to identify content that may be of interest to you, and network
- *Marketing vendors*, such as entities that support distribution of marketing emails.

- **Organizational partners:** We may share your contact information with other. For example, LEE may share information with the LEE Foundation for Civic Engagement Foundation, Inc. other organizations whose participants or members may participate in LEE, organizations and government agencies who host LEE members as fellows, and organizations who receive your donations via the Services. When we disclose information to non-LEE entities, we execute data sharing agreements with those organizations and agencies. All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.
- **Social media platforms:** If you interact with us on social media platforms, the platform may be able to collect information about you and your interaction with. - **Other businesses in the context of a commercial transaction:** We may change our ownership or corporate organization while providing the We may transfer to another entity or its affiliates or service providers some or all information about you in connection with, or during negotiations of, any merger, acquisition, sale of assets or any line of business, change in ownership control, or financing transaction. We cannot promise that an acquiring party or the merged entity will have the same privacy practices or treat your information as described in this policy.

Security

We use a combination of physical, technical, and administrative safeguards to protect the information we collect through the Services. While we use these precautions to safeguard your information and require vendors we contract with to use similar precautions, we cannot guarantee the security of the networks, systems, servers, devices, and databases we operate or that are operated on our behalf.
